98.9 MAGIC FM'S "FALL OUT BOY AT FIDDLER'S GREEN" CONTEST OFFICIAL RULES

Eligibility. Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. Entry comments that are removed and/or blocked by Station and/or by Instagram will be deemed not entered in the Contest.
