98.9 MAGIC FM'S "PIKE'S PEAK OR BUST RODEO 2023" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. By submission of an entry, an entrant releases Instagram from any responsibility or liability for the Contest's administration, prizes, or promotion. An entrant is providing entry information to the Station and not to Instagram.

- Verification of Potential Winner, THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 4.
