## 98.9 MAGIC FM'S "LANY - 989MAGICFM.COM" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KKMG-FM ("Station"), **6805** Corporate Dr., #130 Colorado Springs, CO 80919 during available business hours Monday through Friday, on the Station website <a href="www.989magicfm.com">www.989magicfm.com</a>, or by sending a self-addressed, stamped envelope to the above address. The Station will conduct the "LANY - 989MAGICFM.COM" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

## 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last ninety (90) days and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last ninety (90) days Void where prohibited by law. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. **2.** Contest Period. The Contest entry period will begin at 12:01am MST on February 20, 2024 and will run through 11:59pm MST on February 26, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

## **3. How to Enter.** Entrants must:

- (a) Visit the Station's website at www.989magicfm.com during the Contest Period;
- (b) Locate the "Last Chance: Win Tickets to LANY's Sold-Out Denver Show" page;

(c) Fill out the entry form with all the required information.

Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. Entry comments that are removed and/or blocked by Station will be deemed not entered in the Contest.

- 4. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
